Such comments should specify which of the three documents the comments relate to, including specific details on section or clause for which the comments relate to. Public comments should include the name of the person/stakeholder/ organization submitting comments as well as contact details such as postal address, telephone/cell number and email address. Comments must be emailed to publiccomments@qcto.org.za
